- 3) Threats alternated with kindness





#### TYPES of CHILDREN'S EXPOSURE TO DOMESTIC VIOLENCE & ANIMAL ABUSE:

- 1) Direct witness to violence (see or hear)
- 2) Witness aftermath of violence (injuries, property damage, police response)
- 3) Used by abuser (e.g., spy on victim, forced to watch)
- 4) Injured or at risk as a result of violence
- 5) Sense of guilt for failing to protect others
- 6) Threats to kill or harm animals as means of control adult and children

#### Fostering Resiliency

#### Factors in a Person's Response to Trauma

- Positive perception of mother
- One stable care-giver/ Secure parental attachment
- Sporadic (vs. chronic) abuse
- Peer support
- Safety of community
- Positive parenting characteristics
- Connections to extended family network
- Positive self-image and self-esteem
- Determination to differ from abusive parent / Autonomy
- Strong commitment to school

## **Co-Occurrence**

- Studies show that in roughly half of homes with intimate partner violence the children are directly abused regularly as well
- Batterers are 700% more likely than non-batterers to physically or sexually abuse children

## THE LINK FACTS

- Threats or actual abuse of pets increases probability of intimate terrorism by 38.6% (Fitzgerald et al.,2020)
- Batterers who also abuse pets are more dangerous, more controlling, and use more forms of violence than batterers who do not (Simmons & Lehmann, 2007)
- 62-76 percent of animal cruelty in the home occurs in front of children (Faver & Strand, 2003)
- Children often intervene to protect their mothers and pets from being battered.... Some children may even allow themselves to be victimized to save their pets from being harmed or killed (Edelson et al., 2003)




Victims & non offending caregivers cannot stop the abuse. Only the community can stop the abuser.



## Articulating Danger

- Presence of lethality & risk factors
- Facts of the offense(s) that support a continuing danger to the victim or any other person.
- Defendant's known history of violence,
  - going beyond cases whether Defendant was previously arrested or charged.
- Proximity & access to the victims/ witnesses
- Possession of weapons
- Prior bond/ probation violations
- Prior attempts to escape or failure to obey orders
- Threats or hostility to law enforcement or others <u>Microsoft Word - Rule 33 Recs 8.27.19 (mogor)</u>
